Details of Information Provided

The information has been provided in 8 parts. Background

• Developer Contributions (or Section 106 contributions) are financial payments made to local planning authorities (including the County Council) as part of planning obligations. The contributions help ensure that appropriate development can be accommodated without unacceptable burdens upon existing communities and the environment.

• It is normal, that substantial balances will accrue in Section 106 accounts because of the potential need to await contributions from a number of developments to be received to enable the required infrastructure to be provided. The balances may also arise because payments are often made in instalments (this helps the cash flow of the developer) as a development (e.g. a housing proposal) is built out; consequently to await for sufficient contributions to be collected before infrastructure can be delivered.

• The nature of Section 106 accounts is very fluid, as new contributions are received and others are released to implement schemes. As such, they can only provide snapshot information at any one time.

• Use of Section 106 money is controlled by the legal wording of the relevant agreement. This generally specifies a particular service area (e.g. transport, education), a location and a description of how the contribution can be used. This usually restricts what the council can spend the money on.
